## AUDIT FINDINGS

### **Narrative:**

The Prison Rape Elimination Act (PREA) on-site audit of the M.D.F.T. Girls Intermediate Residential Program, in Litchfield CT was conducted on June 5-6, 2018 by Heidi Pihl-Buckley, a U.S. Department of Justice Certified PREA Auditor for juvenile facilities. Audit notices were posted throughout the facility 6 weeks prior the on-site review and date stamped photographic evidence was submitted demonstrating the timely posting of the notices. As of the date of this report the Auditor has not received any correspondence or mail at the listed addresses.

The M.D.F.T. PREA Coordinator, Dwayne Strawder, completed the On-Line Audit System Pre-Audit questionnaire and it was provided electronically through the OAS. Pre-audit preparation by the Auditor included a thorough review of all documentation provided which included policies, procedures, forms, training curriculum, organizational chart, brochures and other documents supporting compliance with the PREA standards. This review prompted a series of questions that were reviewed during the on-site visits and interviews.

The Auditor was met on Day 1 by Rebecca Hamilton, the PREA Compliance Manager and Laura Pires, the Program Director. After the initial introductions and welcomes the discussion focused on the schedule for the two days.

On the first day of the audit, the Auditor did a brief tour of the facility, to be followed by a complete, more thorough tour on the day 2.

The Auditor was escorted the first day by Laura Pires, Program Director. The Auditor was provided with a private conference room within the administrative floor of the program in which to work and conduct confidential interviews. All staff and youth interviews were conducted in this room. The youth interviews were conducted after school hours to facilitate easy movement of the youth between the residential area upstairs and the office.

Formal, personal interviews were conducted with staff, residents, specialty staff including Clinical and Mental Health as well as Program Administration. All five, or 100% of the youth in the program at the time of the on-site visit were interviewed by the Auditor. Residents were interviewed using the recommended Department of Justice (DOJ) protocols that question their knowledge of a variety of PREA protections both generally and specifically and their knowledge of reporting mechanisms available to them to report abuse or harassment. At the time of the site review there were no transgender or intersex youth in the program.

Nine (9) staff members were interviewed during the on-site review. Included in the interviews were all the staff working at the time including overlapping shifts. Specialty staff included the Nurse and the Clinician. Staff were interviewed using the Department of Justice (DOJ) protocols that question their training and overall knowledge of the agency's zero tolerance policy, reporting mechanisms available to residents and staff, the response protocols when a resident alleges abuse, first responder duties, data collection processes and other PREA requirements.

The Program Director shared all information and files freely, including information on the background check procedures, and youth intakes.

During the on-site review of the physical plant the Auditor observed, among other things, the

configuration, location of cameras and mirrors, staff supervision of residents, program layout including shower/toilet area, placement of posters and PREA informational resources, resident entrance and search procedures and resident programming. The shower areas allow the residents to shower separately as they are individual bathrooms which include a shower and a toilet and sink. Residents are only allowed to dress and undress in the bathroom. The staff monitor the shower by communication in the form of verifying that the youth is OK and keeping to designated times.

The program was very transparent with sharing any and all information requested and in answering any questions the Auditor had. The Auditor was provided with unimpeded access to all parts of the facility during the on-site review.

## AUDIT FINDINGS

### Facility Characteristics:

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. The Multidimensional Family Therapy (M.D.F.T.) Community Residential Program is a family based treatment system for adolescent girls between the ages of 14 and 17 who are struggling with substance abuse and/or behavioral problems. Each girl is assigned a Case Manager and a Clinician. The Case Manager will assist the youth in working with probation officers, school systems, attorneys and other outside resources. The Clinician takes an active role in treatment, meeting weekly with the youth and their families, both individually and as a team when appropriate. Sessions start off on-site but then are typically held at the family's home. Transportation is provided to the homes in program vehicles. The program is a four (4) month program designed to help youth get back on a healthy track and rejoin their families.

Since the last PREA audit in 2015 the Program has moved to a different building on the same campus. The campus houses Touchstone which is a DCF program, a schoolhouse and the MDFT program. The on grounds school is accredited by the CT Department of Education. There are also youth who are living in the community attending the school. Consistent with the national trends around juveniles, this program has also seen a decrease in numbers of youth coming in. The program entry is not secured. There is no fence around the facility. You drive up a long driveway to the program and you would think you were driving on to a very well maintained private residence. The program is extremely clean and well maintained, as are the grounds. The rooms are painted in very inviting colors and nicely decorated. There is no institutional feel to this program. The bedrooms have comforters that you would see in a typical teen-agers room. The living space is very inviting and nurturing. The girls have their own rooms. There are no doors on the bedrooms. There are pictures up throughout the program. There is a kitchen, laundry room, living room, craft room, offices and a gym within the building. Youth are supervised by staff constantly.

There are 24 cameras strategically placed throughout the program. These are monitored by the Program Director. There were 2 blind spots that the Director brought to the attention of the Auditor. They have developed program practices that address the blind spots and are in the process of purchasing cameras for the areas. No cameras had a field of view that included bathrooms, showers or bedrooms.

## AUDIT FINDINGS

### Summary of Audit Findings:

During the past twelve (12) months there were no incidents of sexual assault or harassment reported at this program.

Overall, the interviews with youth, staff and specialized staff reflected an understanding of the PREA protections and the agency's zero tolerance policies. Residents receive written materials at intake that provide detailed information about PREA protections, multiple ways to report sexual abuse and harassment and ways to protect themselves. Residents were able to articulate what they would do and who they could tell of they were sexually abused. Youth consistently stated that they felt safe in the program which is a significant indicator of the positive culture of the program.

All staff interviewed indicated that they had received the PREA training and could articulate the meaning of the agency's zero tolerance policy. Staff were knowledgeable about their roles and responsibilities around prevention, reporting and response to sexual abuse and sexual harassment. Staff consistently reported a variety of avenues for residents and staff to report sexual harassment and abuse. Interviews supported that staff are professional and dedicated to ensuring that youth are safe and receive the services they need to turn their lives to a more positive trajectory.

In summary, after reviewing all pertinent information, conducting an on-site review including resident interviews and staff interviews, the Auditor found that the agency leadership has clearly made PREA compliance a high priority, They have devoted a significant amount of time to policy development, training of staff and education of residents on all of the key aspects of PREA.

<b>115.311</b>	<b>Zero tolerance of sexual abuse and sexual harassment; PREA coordinator</b>
	<p><b>Auditor Overall Determination:</b> Meets Standard</p>
	<p><b>Auditor Discussion</b></p> <p>The agency (NAFI) and facility (M.D.F.T. Girls Intermediate Residential) have written policies that set forth clear expectations with regard to zero tolerance for all forms of sexual abuse or sexual harassment. The tone of zero tolerance is observable throughout the facility as evidenced by posters, handbook and interviews. Policy Number C.13 effective October 1, 2013 details prevention, detection and response to sexual abuse and harassment. This is the only program operated by the agency that falls under the PREA standards. The definitions of prohibited behaviors are clearly defined as are sanctions for violations of the policy. The agency has a designated PREA Coordinator (Dwayne Strawder) who works together with a Compliance Manager, (Rebecca Hamilton). They both stated that they have ample time to accomplish and oversee the PREA Legislation.</p> <p>The state of CT funds this program through the Court Support Services Division which also monitors through the Office of the Child Advocate (OCA).</p>

	<b>Auditor Discussion</b>
	The program is under the auspices of the State of CT Court Support Services who provides the funding. They do not contract out for any confinement services.

<b>115.313</b>	<b>Supervision and monitoring</b>

	<b>Auditor Discussion</b>
	This program is a non-secure facility so this standard is N/A. There is however, strong oversight of the entire operation with many different entities from the funder, to agency, to monitors with oversight.

<b>115.315</b>	<b>Limits to cross-gender viewing and searches</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>NAFI policy states, "At no time does this agency condone random searches. In addition, the agency does not condone strip searches, pat down searches and/or visual body cavity searches. The agency does not search or physically examine a transgender or intersex youth for the sole purpose of determining the resident's genital status." It was confirmed during both staff and youth interviews that cross gender strip or pat searches, visual body cavity searches, or cross gender pat down searches are never a practice at this program, even in exigent circumstances. This program conducts an initial screening prior to the youth being considered for the program. The initial screening is for Vulnerability to Victimization and Sexually Aggressive Behavior. It asks, "Do you identify as lesbian, gay, bisexual, transgender or questioning?" and "Are you perceived by others as being lesbian, gay, bisexual, transgender or questioning?". The method used to search youth involves having the youth stand in a room with the staff on the other side of the doorway and visible to the video camera. Youth are not required to take off their clothes. They are directed to take off their shoes and socks. They are directed to pull out their bra, run their fingers through their hair. It is a very non-obtrusive search with the youth remaining clothed and staff never touching them.</p> <p>Staff would conduct the same search for transgender or intersex youth although they have not had any youth identifying as such. All toilets are private, and all showers have curtains. Staff are positioned throughout the hallway when youth are in their bedrooms, showering or using the toilet. The practice is for staff to never step into a room without a witness. Cameras are placed to view the staff location in the hallway. The only location youth dress and undress is the toilet/shower area which are is out of camera view. Staff strictly monitor this area to insure there is only one youth in the bathroom at a time.</p>

<b>115.316</b>	<b>Residents with disabilities and residents who are limited English proficient</b>

	<p>Policy prohibits the use of resident translators. Youth confirmed through interviews that they are not asked to act as translators.</p>

<b>115.317</b>	<b>Hiring and promotion decisions</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>Policy states, "The agency shall not hire a potential employee or contractor who has engaged in sexual abuse in a prison, jail, lock-up, community confinement facility or juvenile facility or other institution." Policy also includes those "convicted of engaging or attempting to engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse." Volunteers and Interns are included under this policy with the same prohibitions to hire. Criminal Background checks are completed on every employee. Prior to hire a check is conducted with DCF/Child Protective Services. This is repeated every 2 years or more often. There is also a Department of Motor Vehicle check prior to hire and annually. Fingerprinting is completed by the CT State Police. There is a database of all staff records on checks that flags when an update is needed. Agency policy states that materially false information shall be grounds for termination.</p>

<b>115.318</b>	<b>Upgrades to facilities and technologies</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>The location of the primary residence for the girls has changed buildings since the PREA audit of 2015. The Director of Maintenance has been instrumental in making sure the program is compliant. There are cameras placed throughout the program, with two blind spots (pointed out by Program Director) that staff are vigilant about monitoring. The current practical approach to addressing the blind spots was shared with the Auditor and would avoid any issues with the area being unmonitored. There are new video cameras on order to eliminate these particular issues. The agency has given careful thought to the placement of the cameras to ensure the safety of all.</p>

<b>115.321</b>	<b>Evidence protocol and forensic medical examinations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The facility does not conduct administrative investigations but refers them to the Department of Children and Families (DCF). Criminal investigations are referred to the CT State Police. Forensic exams would be conducted by SANE Nurses at the Charlotte Hungerford Hospital. There would be no cost associated with this exam that would be the responsibility of the youth. The facility has a memorandum of understanding with the Susan B. Anthony Project.</p>

<b>115.322</b>	<b>Policies to ensure referrals of allegations for investigations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>M.D.F.T. ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment. In the event that a youth alleges sexual abuse, staff members are required to immediately notify the Program Director. There is a specific process to follow upon notification. Policy states the agency does not conduct, nor is it responsible for conducting, any form of criminal or administrative sexual abuse allegations. If incident is of a criminal nature the HR Manager will contact the proper authorities, e.g., Local Police, State Police, DCF Caroline or Office of Protection and Advocacy, and notify them of the incident.</p> <p>There have been no PREA related youth on youth sexual harassment allegations made in the last 12 months.</p>

<b>115.331</b>	<b>Employee training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>All staff interviewed confirmed they had received formal training on all required topics. The Program provided copy of the curriculum used, which is very comprehensive and includes scenarios for discussion that cover all PREA topics through a practical approach. Staff are required to sign off that they understand the zero tolerance policy and their responsibilities around reporting. The Auditor discussed the PREA training in detail with the Program Director, who is also the PREA Trainer and was very knowledgeable in all content.</p>

<b>115.332</b>	<b>Volunteer and contractor training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	At this time the facility does not utilize volunteers.

<b>115.333</b>	<b>Resident education</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The commitment of this program to ensuring youth understand their right to be safe is exceptional. The facility has several avenues by which youth receive PREA information. Upon intake to the facility residents receive a handbook. Under the Community Safety Guidelines section of the handbook, the touch policy defines appropriate behaviors in a kid friendly way. Youth are also given the PREA brochure which defines sexual abuse and harassment, gives examples, describes how to prevent and report. It includes contact information for the Agency PREA people, the CT sexual assault crisis service, the DCF hotline and the Susan B Anthony Project. There is additional information in the form of an In Service upon intake titled Your Safety at NAFI, CT, Inc. The information is very comprehensive in defining PREA, describing the rights youth have, and detailing how to report. All of the youth interviewed stated they received the information at intake.</p>

<b>115.334</b>	<b>Specialized training: Investigations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	The program does not conduct criminal investigations.

<b>115.335</b>	<b>Specialized training: Medical and mental health care</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The medical and mental health staff at the program receive regular training to maintain certifications. Interviews revealed mental health and medical practitioners employed at the program clearly understand how to detect and assess signs of sexual abuse and sexual harassment, how to preserve physical evidence of sexual abuse, how to respond effectively and professionally to juvenile victims, and to whom allegations should be reported. The program does not conduct any forensic evaluations. Youth would be taken to the hospital were trained nurses would conduct the exam. Mental health and medical practitioners participate in the full PREA training, as do all staff working at the program.</p>

<b>115.341</b>	<b>Obtaining information from residents</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>All youth are assessed for risk to self and others upon intake. The program has a standard screening form with all of the risk factors listed, however some of the questions are not objective and require opinion based findings. There is also some outdated language that needs to be cleaned up. Once this is completed they will be in compliance with the standard. The screening is conducted immediately upon admission to the facility. The screening consists of questions for the youth, as well as staff review of information provided by probation, parents, sentencing notes, and any reports.</p> <p>The screening is conducted upon intake so it is well within the guidelines.</p>

<b>115.342</b>	<b>Placement of residents</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>Isolation is never used for any reason with the youth in the program.</p> <p>The facility places youth who are referred to them by the court.</p> <p>There were no gay, bisexual, transgender, or intersex youth in the program during the audit. While they did not have any transgender youth in the past 12 months the interviews discussions revealed that the agency would place a biological boy who identified as a female at this program if they were referred.</p> <p>Interviews with facility leadership indicated that all information obtained during intake is used to ensure this is an appropriate placement for the youth.</p> <p>The Auditor is worked with the Program as part of the corrective action plan and they created a policy, "Prohibition of Harassment and Discrimination Against Youth" and practice to ensure placement is not based on anatomy alone. The screening tool used by the program was updated. The youth are screened by the courts prior to placement, therefor the selection of youth to be placed here is somewhat out of the control of the program.</p>

<b>115.351</b>	<b>Resident reporting</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The youth interviewed could all discuss multiple ways that they could address and report sexual abuse, harassment, retaliation or any staff negligence. It is important to note that these youth are all very involved in the community and can actually leave the program if they want to. Numbers are posted throughout the program allowing for one avenue to report. Youth stated they could tell a Parent, Probation Officer, Lawyer or listed specific staff members they would feel comfortable speaking to. They also mentioned the Clinical staff or the Program Director as an option for reporting. The Program Director is very visible on the floor and would be accessible to any youth if they needed to report. The youth handbook details behaviors that are in violation of community expectations, including harassment, threatening, and relational aggression. Staff also confirmed that they would accept reports from the youth and immediately pass the information through the appropriate channels. Staff and youth were aware of the DCF 800 number. Youth are permitted to call their attorneys on a daily basis. They have frequent contact with their Probation Officers.</p>

<b>115.352</b>	<b>Exhaustion of administrative remedies</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>Auditor observed that youth at this program have strong relationships with staff. They are all aware of how they would file a grievance. All youth interviewed stated they would just talk to a staff member and could name a particular staff person to talk to. They also stated that they can file a grievance by putting it in the grievance box. There are 2 separate boxes, one for program specific issues that is opened by the Program Director and another opened by the Monitor for the Court.</p> <p>There is no specific policy for emergency grievances. The Auditor is working with the program to come into compliance with this standard by developing procedures and practices. A template of a policy that meets the standard was shared with the program.</p>

<b>115.353</b>	<b>Resident access to outside confidential support services and legal representation</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The program has a MOU with the Susan B. Anthony Project to provide support services for youth. Posters are placed prominently throughout the building and all youth interviewed stated they are aware of their right to call and make reports. All of the youth in the placement are referred by the court and have access to their probation officer. Resident are allowed unmonitored communication with Probation Officers and Lawyers. Youth are very connected with the community which would allow for outside avenues to report. All youth reported being allowed phone calls to parents/guardians on a daily basis. Parent/guardian involvement is a major part of this program. None of the youth reported being denied access to their attorneys. Family involvement is the foundation of this program so youth have access to contact with their families. Clinical work with families takes place at the youth's home after the first month.
